**Subject: All India Trade Test (AITT) Supplementary – November, 2022 CBT examinations for Supplementary trainees of Annual System and Semester System -reg.**

Sir,

In continuation to letter of this Directorate vide even no dated 17<sup>th</sup> Oct 2022 regarding supplementary examination of Annual System and Semester System, various requests were received from State directorate and ITIs to allow trainees whose eligibility was not created for mains examination. The matter was deliberated upon and it is decided to allow such trainees for filling eligibility. Accordingly, the NCVTMIS Portal has opened for filling eligibility criteria for the following batches. Trainees will be visible for CBT fees payment after approving H1/H2 and Formative assessment.

S.no	Session	Trainee Type	Eligibility Criteria
1	2018,2019 and 2020	One year course, Two year course, 6 month course	Formative Assessment Attendance Examination Fees
2	2021	First year of 2 year course, one year course & 6 month course	-do-
3	Semester system (2014-2017)	One year course, Two year course, 6 month course	Sessional Attendance Examination Fees

Further, there were cases received wherein trainees were not visible for supplementary examination. These cases were analyzed and it has been found that such trainees have not paid their CBT fees for earlier examinations. Now provision has been made for such trainees at ITI level to pay the CBT fees of earlier examination as well as for current examination as detailed below.

**Total CBT fees = CBT fees(Current examination)+ Pending CBT Fees.**

It is further informed that ITI can start filling eligibility for trainees who are willing to appear in Practical/ED for following sessions.

2	2021	First year of 2 year course, one year course & 6 month course
3	Semester system (2014-2017)	One year course, Two year course,6 month course

State Directorates can collect fees for Practical/ED examination. Timetable for Practical/ED will be issued shortly. It may be noted that trainees who have already appeared in March 2022 examination need not register for ED/Practical as the results have not been declared yet. However, such trainees can register for CBT examination. List of not appeared trainees will be shared with State Directorate .

Further , CBT fees payment date has been extended till 20<sup>th</sup> Nov 2022 and CBT examination shall start tentatively from 10<sup>th</sup> Dec 2022 onwards. There will be no further extension of CBT examination fees payment date.
